SUBJECT: No Parking Zone on Grand Avenue in the Los Olivos Area;

Third Supervisorial District

RECOMMENDATION:

C.A. Recommendation:

That the Board of Supervisors adopt a resolution establishing a "No Parking" zone on Grand Avenue in the Los Olivos area.

ALIGNMENT WITH BOARD STRATEGIC PLAN:

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure.

EXECUTIVE SUMMARY & DISCUSSION:

Grand Avenue is a major-collector roadway running north and south in Los Olivos with fronting residences and various businesses at the east and west sides of the roadway.

Public Works has been working with the Wine Country Inn in Los Olivos to address a safety concern in front of the Inn. There is a drainage outlet located in front of the entrance, which may cause pedestrians to slip and fall when they park and step up or down from the sidewalk. It was decided that the best solution would be a chain barrier to prevent pedestrians from crossing the curb at this location. The chain will be installed by the Permits and Construction Section of Public Works.

To supplement this chain barrier, it is necessary to restrict the parking immediately in front of the drainage inlet. The Public Works Traffic Section has prepared the attached resolution establishing a "No Parking Zone" at the following location.

• On the east side of Grand Avenue from a point 80 feet north of the centerline of Hollister Street to a point 110 feet north of the centerline of Hollister Street.
