AN ORDINANCE AMENDING THE SANTA BARBARA COUNTY LAND USE AND DEVELOPMENT CODE, SECTION 35-1 OF CHAPTER 35, ZONING, OF THE SANTA BARBARA COUNTY CODE TO AMEND THE COUNTY ZONING MAP BY ADDING A NEW SENIOR MOBILE HOME PARK (SMHP) OVERLAY AND MOBILE HOME PARK (MHP) OVERLAY ZONE AND REZONING CERTAIN PARCELS TO IMPLEMENT A PART OF THE SENIOR MOBILE HOME PARK OVERLAY ORDINANCE AMENDMENTS PROJECT.

The Board of Supervisors of the County of Santa Barbara, State of California, ordains as follows:

SECTION 1:

Pursuant to the provisions of Subsection E, Map Amendments, of Section 35.14.020, Zoning Map and Zones, of Chapter 35.14, Zoning Map, and Chapter 35.104, Amendments, of Section 35-1, the Santa Barbara County Land Use and Development Code, of Chapter 35, Zoning, of the Santa Barbara County Code, State of California, the Board of Supervisors hereby amends the County Zoning Map by adding two new zoning overlays, the Senior Mobile Home Park (SMHP) Overlay Zone and the Mobile Home Park (MHP) Overlay Zone, and re-designating the parcels as shown on table titled "Assessor's Parcel Numbers For Land Use And Development Code County Zoning Map Amendments" (Exhibit 1), attached hereto and which are made a part of said section by reference.

The amended County Zoning Map is made part of said section by reference, with the same force and effect as if the boundaries, locations, and lines of the districts and territory therein delineated and all notations, references, and other information shown on said zoning map were specifically and fully set out and described therein.

SECTION 2:

The Chair of the Board of Supervisors is hereby authorized and directed to sign and certify this Ordinance and all maps, documents, and other materials in said Exhibit 1 to show that said exhibit maps and zoning changes for the parcels identified in Exhibit 1 have been adopted by this Board of Supervisors.

SECTION 3:

Except as amended by this Ordinance, Chapter 35.14, Zoning Map, of Article 35.1 of Section 35-1, the Santa Barbara County Land Use and Development Code, of Chapter 35, Zoning, of the Santa Barbara County Code shall remain unchanged and shall continue in full force and effect.

SECTION 4:

This ordinance shall take effect and be in force 30 days from the date of its passage and before the expiration of 15 days after its passage a summary of it shall be published once together with the names
