SUBJECT: Construction of 2000/2001 STIP Rehabilitation of Via Los Santos, San Antonio Creek Road and Paradise Road in the Second and Third Districts, Santa Barbara County, County Project No. 810463

Recommendation(s):

That the Board of Supervisors:

- A. Approve plans and specifications for Construction of 2000/2001 STIP Rehabilitation of Via Los Santos, San Antonio Creek Road and Paradise Road in the Second and Third Districts, Santa Barbara County, County Project No. 810463 and
- B. Award the construction contract in the amount of \$546,904.40 to the lowest responsible bidder, Nye & Nelson, Inc., (not A Local Vendor), 1860 Eastman Avenue #108, Ventura, CA 93003, subject to the provisions of documents and certification, as set forth in the plans and specifications applicable to the project and as required by law; and
- C. Authorize the chair to execute the construction contract upon return of the Contractor's executed contract documents and the review and approval of the County Counsel, Auditor Controller and Risk Manager or their authorized representatives: and
- D. Approve a contingency fund in the amount of \$39,845.22 for Construction of 2000/2001 STIP Rehabilitation of Via Los Santos, San Antonio Creek Road and Paradise Road in the Second and Third Districts, Santa Barbara County, County Project No. 810463.

{Double-click here} **Executive Summary and Discussion:**

On Thursday, May 23, 2002, seven (7) bids were opened for the Construction of 2000/2001 STIP Rehabilitation of Via Los Santos, San Antonio Creek Road and Paradise Road in the Second and Third Districts, Santa Barbara County, County Project No. 810463. Nye & Nelson, Inc., was the lowest responsive and responsible bidder in the amount of \$546,904.40, which was 6% above the Engineer's Estimate. Staff recommends awarding this contract to Nye & Nelson, Inc., a California Corporation.



The project consists of in-place recycling of the existing structural section, removing excess material, regrading and compaction of the remaining structural section and paving with Type B asphalt concrete. Approximately 4.51 lane miles of County maintained roadway will be recycled and resurfaced with the construction of this project.

Your Board approved the project as part of the 2001/2002 Capital Improvement Plan. The specific project locations were approved by your Board in the FY 2001/2002 Road Maintenance Annual Plan (RdMap).

This project was bid in accordance with the Public Contract Code, which requires the award to the lowest responsible bidder.

Mandates and Service Levels:

No change in programs or service levels.

Fiscal and Facilities Impacts:

This project will be fully reimbursed by the State Transportation Improvement Program (STIP). Funding for the project is budgeted in Fund 0015, Program 2900, Org Unit 0001, Department 054 and Account 7510. The allotment is included in the construction cost center of the Transportation Division on page D292 of the fiscal year 02/03 adopted budget.
