- A. Accept the offer of dedication of public utility easements as defined on Parcel Map No. 14,748 by authorizing the Clerk of the Board to sign said map. Consummation of the easement acceptance is subject to completion and recordation of the subject map; and
- B. Accept the CEQA Negative Declaration prepared for the subject Parcel Map.

Summary Text:

The County Surveyor's Office is reviewing Parcel Map No. 14,748 regarding the parcel known as APN 137-270-030 (the "Property") located near the City of Solvang in the Third Supervisorial District. If recorded the above Map will split the Property into two legal parcels and will grant a variable width public utility easement. The lot split and easement acceptance will not be consummated until the subject parcel map is recorded. Prior to recordation the County Surveyor will be satisfied that the subject parcel map is technically correct, conforms to the approved Tentative Map (or approved alterations thereto), and complies with all applicable laws and regulations.

The proposed lot split and public utility easement was studied in accordance with the California Environmental Quality Act. That study resulted in Negative Declaration 09NGD-00000-00011.

Background:

Via submittal of Tentative Parcel Map 14,748 the property owner proposed splitting the 205 acre Property into two legal sized residential parcels each consisting of approximately 103 acres. The Tentative Parcel Map was approved by the Santa Barbara County Planning Commission at its regularly scheduled meeting of October 21, 2009.

The Tentative Parcel Map was studied in accordance with the California Environmental Quality Act, which study resulted in the Negative Declaration known as 09NGD-00000-00011. That Negative Declaration was adopted by the Planning Commission at the above referenced October 21, 2009 meeting and has been filed for public viewing.
