REIMBURSEMENT AGREEMENT BETWEEN THE SANTA BARBARA COUNTY SHERIFF'S OFFICE AND THE STATE OF CALIFORNIA DEPARTMENT OF JUSTICE BUREAU OF INVESTIGATION

This Reimbursement Agreement (RA) is to establish that the Santa Barbara County Sheriff's Office enters into an agreement with the California Department of Justice (DOJ), Division of Law Enforcement (DLE), for the purpose of reimbursement.

The Santa Barbara County Sheriff's Office agrees to reimburse the DOJ for the salary and benefits of the Task Force Commander of the Santa Barbara Regional Narcotic Enforcement Team (not to exceed \$110,000, which includes 5% longevity¹; \$100 education, \$65 physical fitness, and \$250 task force commander pay) for the period of **July 1, 2012 through June 30, 2013**. The Task Force Commander's (Special Agent Supervisor) salary and benefits will be paid by the DOJ. The Santa Barbara County Sheriff's Office will then reimburse the DOJ in accordance with the provisions of this agreement.

Requests for reimbursement shall be made on a monthly basis as soon as practical following the month for which reimbursement is requested. Expense invoices will be prepared by the DOJ and provided to the Santa Barbara Sheriff's Department for reimbursement.

The DOJ shall bill the Santa Barbara County Sheriff's Office at 4434 Calle Real, Santa Barbara, CA 93111, Attention: Business Office. The Santa Barbara County Sheriff's Office will reimburse the DOJ by issuing a check to: California Department of Justice, 1300 "I" Street, Room 810, Sacramento, CA 95814, Attention: Cashiering Unit.

This agreement may be terminated by either party upon thirty (30) days written notice to the other party. The Santa Barbara County Sheriff's Office and the DOJ have executed this agreement through their duly authorized officers effective the day and year set forth herein.
