Dear Honorable Members of the Board of Supervisors:


At the Planning Commission hearing of February 7, 2007, Commissioner Smyser moved, seconded by Commissioner Blough and carried by a vote of 5-0 to recommend that the Board of Supervisors:

1. Receive and file the *2007-2008 Annual Work Program and Mid-Year Report for Land Use Planning Projects and Policy Initiatives*.
2. Direct staff of the Office of Long Range Planning to work on potential new projects 1-12 listed in Table 2 of the *2007-2008 Annual Work Program and Mid-Year Report for Land Use Planning Projects and Policy Initiatives*, and defer Items 13 A and B until the Public Works Transportation Study is complete.

In a separate motion at the Planning Commission hearing on February 7, 2007, Commissioner Smyser moved, seconded by Commissioner Blough and carried by a vote of 5-0 to direct staff to return to the Planning Commission for a fuller discussion of the following:

1. A longer term listing of potential new projects categorized by short, mid and long term or by years.
2. A Lompoc Community Plan.
3. Some consideration of an Open Space Element.
4. General coordination of all agricultural issues, which are part of the Work Program recommendations.
