Review and approve the Statement of Final Quantities for work performed and materials supplied for this project by the Contractor, DeBruin Construction (Not a Local Vendor), P. O. Box 1355, French Camp, CA 96231, in the amount of \$380,760.35.

Alignment with Board Strategic Plan:

The recommendations are primarily aligned with Goal No. 1, An Efficient Government Able to Anticipate and Respond Effectively to the Needs of the Community.

Executive Summary and Discussion:

This project consisted of the minor rehabilitation of seven Santa Barbara County bridges (see table below). With this project, five structures at various locations in the County were rehabilitated with a methacrylate deck seal. This sealant was designed to penetrate cracks in the existing bridge decks, to prevent further damage to the structure, and to help provide a longer lifespan for these structures. The other two structures were deteriorated past the stage of crack sealing and required an overlay of polyester concrete to the bridge deck surface.

This project was approved as a part of the FY 03/04 Capital Improvement Plan. Project locations were approved in the 2003/2004 Road Maintenance Annual Plan. This project was bid in accordance with the Public Contract Code, which requires the Department to award to the lowest responsible bidder.

The Director of Public Works accepted this project as complete on March 3, 2004. The project was completed on time and on budget.
