#### **Summary Text:**

The project consisted of resurfacing 1.25 lane miles on Hollister Avenue from Modoc Road to 2,200 linear feet west of Modoc Road and at the intersection of Hollister Avenue and Turnpike Road. Resurfacing work included repairing failed areas and placement of a three-layered system of a leveling course, stress absorbing membrane interlayer (SAMI) and Type B asphalt concrete overlay.

The project was accepted as complete by the Director of Public Works on April 16, 2007.

This project was completed on time and under budget.

# **Background:**

The project location was approved by your Board in FY 2006/07 Road Maintenance Annual Plan (RDMap) on March 28, 2006, and is part of the 2004 State Transportation Improvement Program Roadway Rehabilitation Project. The project was awarded to Granite Construction Company by your Board on October 17, 2006.
