Dear Shawna Morris,

In accordance with Section 19 (Termination) of the above-referenced Agreement, the County of Santa Barbara Department of Behavioral Wellness issues this notice of its intent to partially terminate the Agreement for convenience, specifically the Safe Alternatives for Treating Youth (SAFTY) Program, and all related terms as more fully described below, effective September 30, 2025. Casa Pacifica requested the early termination of this program for budgetary reasons.

Behavioral Wellness will seek the County Board of Supervisors' approval of the partial termination of the Agreement on or around October 14, 2025. Contingent upon the Board's approval, partial termination will be effective for the terms listed below. Instructions concerning the wind-down process will follow this notice.

- Exhibit B-1 MHS Schedule of Rates and Contract Maximum.


