Summary Text:

The thirty year plus heating system in the Lompoc Administration building needed replacement due to age, lack of controls, increasing frequency of failures and difficulty locating parts, which increased maintenance and operational costs.

Background:

The original gas fired multi zone heater for the building was over thirty years old and was failing regularly. Repairs on this unit were complicated and difficult as many replacement parts were no longer available. The cost to operate, maintain and control the unit continued to increase, as well as the number of failures. The new heating system is more energy efficient in natural gas consumption, can be more accurately controlled for the different "zones" and during the retrofit the remote control capability via the NOVAR controls was enhanced which allows for remote diagnosis. The project went well and the new heater was functioning in time for the start of the winter. The project was completed on time and on budget.
