The State of California has awarded the Sheriff's Office \$117,200 in grants funds to continue for the Rural Crime program. The award period is from October 1, 2011 through September 30, 2012. The Rural Crime program was discontinued and the position eliminated during the development of the FY2011-12 budget due to the apparent loss of funding. Subsequent to the adoption of the Sheriff's Office budget, the State reinstated the Rural Crime grant. This revision recognises the entire amount of the grant in FY2011-12, with salary & benefits costs for a full time Deputy Sheriff, some equipment, liability insurance and funding for the use of a vehicle. Since the grant is good until September 30, 2012, the Sheriff's Office will rebudget any unused grant funds in FY2012-13.
