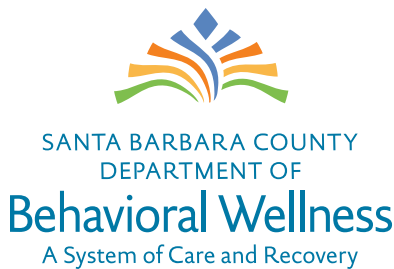

In accordance with Section 19 (Termination) of the above-referenced Agreement, the County of Santa Barbara Department of Behavioral Wellness issues this notice of its intent to partially terminate the Agreement for convenience, specifically Perinatal Services, within the Alcohol and Drug Programs (ADP) Early Intervention, Outpatient Treatment Services, and Intensive Outpatient Treatment Services, and all related terms as more fully described below, effective October 29, 2025. CADA has requested the early termination of these services in consideration of limitations in organizational capacity, staffing, physical space, as well as decline in referrals and need.

Behavioral Wellness will seek the County Board of Supervisors' approval of the partial termination of the Agreement on or around December 16, 2025. Contingent upon the Board's approval, partial termination will be effective for the terms listed below. Instructions concerning the wind-down process will follow this notice.

The following Agreement terms are subject to this notice:

- Exhibit A- 2 ADP – Early Intervention Services, Outpatient Services, Outpatient Treatment Services, and Intensive Outpatient Treatment Services;
- Exhibit E ADP – Program Goals, Outcomes and Measures.
