### Alignment with Board Strategic Plan:

The recommendations are primarily aligned with Goal No.1: An Efficient Government Able to Respond Effectively to the Needs of the Community; and Goal No. 2. Ensure the Public Health and Safety and Provide Essential Infrastructure.

# **Executive Summary and Discussion:**

The proposed project consists of the reconstruction of the southern section of designated apron, approximately 45,000 square feet and reconstruction of a designated approach road, approximately 5,000 square feet in area.

The existing structural section is assumed to be two to three inches of asphalt pavement over a section of oiled sand or aggregate base. While the surface has performed well, significant cracking, local failure, rutting, vegetation growth, and surface depression is occurring. Several of the failure modes are an indication that the pavement has achieved its design life. The new section will include construction of an engineered native subgrade, placement and compaction of pulverized material generated from this project, compacted aggregate base, and a surface course of asphalt pavement.

Construction of the project is scheduled to begin in summer of 2004, after the rainy season has passed. All work will be completed before December of the same year.

This project is to be constructed through a Federal grant administered through the Federal Aviation Administration (FAA). Projects are Federally funded to 90% with 5.5% match from the local sponsor (Santa Ynez Valley Airport Authority) and 4.5% from the State of California through Caltrans, Division of Aeronautics.

# **Fiscal and Facilities Impacts:**

Funding for this project is provided by a grant from the Federal Aviation Administration (FAA) in the total amount of Two-Hundred three thousand four hundred and fifty six dollars (\$203,456.00). Ninety-percent (90%) or, One-hundred and eighty three thousand one hundred and ten dollars (\$183,110.00) is funded by the FAA. The State of California-Department of Transportation State Matching Grant is 4.5% or Nine thousand one hundred and fifty six (\$9,156.00). The Santa Ynez Valley Airport Authority is paying the local share of 5.5% or Eleven thousand one hundred and ninety dollars (\$11,190.00).
