Recommended Actions:

That the Board of Supervisors considers recommendations as follows:

- a) Approve, ratify, and authorize the Chair to execute a Second Amendment to the Memorandum of Understanding (MOU) between the Public Health Department (PHD) and Santa Barbara Neighborhood Clinics (SBNC), which facilitates patient referrals between the agencies, to extend the term through June 30, 2022; and
- b) Approve and authorize the Director of Public Health to extend the MOU for an additional two years through June 30, 2024 in accordance with Section 6.A. of the MOU; and
- c) Determine that the recommended actions do not constitute a "Project" within the meaning of the California Environmental Quality Act (CEQA), pursuant to Section 15378(b)(5) of the CEQA Guidelines, because the actions consist of the organization and administrative activities of the government that will not result in direct or indirect physical changes in the environment.

Summary Text:

This item is on the agenda to authorize the Chair to execute a Second Amendment to the MOU with Santa Barbara Neighborhood Clinics (SBNC) to extend the term through June 30, 2022. This MOU constitutes an in-kind exchange of administration services by each organization. Any patient billing or third party billing is specified within the MOU as the responsibility of the respective organization.

PHD and SBNC have worked collaboratively for a number of years to provide medical services to the uninsured and underinsured residents of Santa Barbara County. Both organizations are Federally Qualified Health Centers. SBNC provides both primary care medical and dental services, and PHD provides both primary care medical and specialty services. Both organizations have provided referrals to the other organization to provide access to both dental services and specialty services.
