Executive Summary and Discussion:

On February 10, 2003, EDAC reviewed the membership applications for the UCSB's Center for Entrepreneurship & Engineering Management (CEEM) and the Santa Barbara Public Education Foundation (SBPEF). The EDAC members present voted unanimously to recommend that the Board of Supervisors add these organizations and appoint their representatives to EDAC.

EDAC's By-laws, Article III, Section 2, state that "Each organization identified in Article III, Section 1 shall designate its representative to serve on EDAC (and may designate an alternate representative). Members and alternates are appointed by a majority vote of the Board of Supervisors for a term of one year. Members and alternates may be reappointed."
