Title: Increase Appropriations for Board of Supervisors First District Discretionary Funds

Budget Action: Increase appropriations of \$155,442 in General County Programs General Fund for Services and Supplies funded by \$6,222 release of Committed General County

Programs fund balance and \$149,220 release of Committed Emerging Issues fund balance.

Justification: This budget revision is necessary to release funds held in General County Programs Committed fund balances for discretionary spending by the Board's First District

Office, so that the district may direct funding to projects and/or programs in the County that are in need of funding and that meet the social needs of the community. \$6,222 is the current balance held for the first district in the Committed General County Programs fund balance and is an accumulation of this district's remaining prior year unspent funds from the annual \$7,500 allocated to each district office. A total of \$149,220 is also being released from the Emerging Issues Committed fund balance which represents the remaining balance of two separate allocations to the district for discretionary spending in FYs 2022-23 (\$73,000) and 2023-24 (\$100,000) that went

unspent. Releasing these funds from fund balance will allow the district to direct funding to projects and/or programs in the current fiscal year, as needed.
