Recommended Actions:

That the Board of Supervisors:

- A. Approve and execute the attached contract with W. Haywood Burns Institute to provide technical assistance for the period of October 1, 2016 through September 30, 2017, not to exceed amount of \$75,000.00.
- B. Determine that the approval of the Agreement is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15061(b)(4), finding that this activity is covered by the general rule that CEQA applies only to projects which have the potential for causing a significant effect on the environment, and where it can be seen with certainty that there is no possibility that this activity may have a significant effect on the environment, the activity is not subject to CEQA, and direct staff to file a Notice of Exemption (Attachment B).

Summary Text:

W. Haywood Burns Institute has been providing technical assistance regarding the Reducing Racial and Ethnic Disparity (R.E.D.) Grant to the Probation Department since 2014.

Background:

Probation initially received the R.E.D. grant in 2014 for phase one of our efforts to address racial disparity in Santa Barbara County. Through a non-competitive application process, phase two funding was received in 2015 and phase three funding, for the current federal fiscal year (October 1, 2016 through September 30, 2017), was received in October 2016. The W. Haywood Burns Institute has provided technical assistance since the inception of the grant.

Racial and ethnic disparity refers to unequal treatment of youth of color in the juvenile justice system; R.E.D. results in disparate outcomes for similarly situated youth. The W. Haywood Burns Institute utilizes a data-driven process during a two to three year consultation period to strategically reduce disparity. They have provided consultation in 90 jurisdictions to date and have helped jurisdictions across the country significantly reduce racial and ethnic disparity.

The goals for this phase of the R.E.D. grant is to review and revise the juvenile hall intake assessment form and process, develope a "violation of probation" database, and provide training for probation staff.

Performance Measure:

- 1. Facilitate 8-10 on-site R.E.D. committee meetings.
- 2. Development and automation of the juvenile hall intake assessment tool.
- 3. Revision of existing probation response grid.
- 4. Facilitation of probation officer training.
- 5. Development of countywide Youth Advisory Board.
