Title: Establish Appropriations in Social Services Fund 0058 for the NFJP Grant

Budget Action: Establish appropriations of \$1,500,000 in the Social Services Department in WIOA-WDB fund for Salaries and Benefits of \$501,211 and Services and Supplies of

\$998,789 funded by unanticipated revenue from Intergovernmental Revenue-Federal by the US Department of Labor.

Justification: The County of Santa Barbara Workforce Development Board was awarded a 51-month National Farmworker Jobs Program grant by the US Department of Labor in the

amount of \$7,999,996. This grant award, along with other existing grants, will help fund the WDB's Farmworker Resource Center program. The first piece of the award, covering July 1, 2024 through September 30, 2025, is \$1,999,999. There will be three additional annual awards of \$1,999,999 covering October 1, 2025 through

September 30, 2028.

The impact to Fiscal Year 2024-25 is \$1,500,000. DSS projects to incur grant-related expenditures of \$501,211 for salaries and benefits, \$191,250 for direct job seeker costs, \$7,500 in equipment, \$2,250 in travel, and \$797,789 in contractual services. DSS will build appropriations for the balance of the award into its Fiscal Year 2025-26 budget. The additional annual awards of \$1,999,999 will be incorporated into future DSS budgets.
