- 1.4 FTE Evening Registered Nurse
- 0.60 FTE Medical Director Pediatrician
- 1.0 FTE Administrative Assistant



# **Healthcare Services**

- Initial medical receiving screen
- Initial mental health screen
- Withdrawal monitoring and treatment from intake
- Medication-assisted treatment (MAT), including naltrexone and buprenorphine
- Medical care in a clinic setting
- Nursing protocols to guide care
- Continuation of care, including medications
- Chronic care management of chronic diseases
- Laboratory testing
- On-call provider 24/7
- Suicide prevention protocols and training

- Discharge planning (discharge meds & connection to outside services on release)
- Pharmaceutical management
- STI testing
- Oral Screening
- Referral for dental care
- Vision Screening and referral to Optometrist and prescription glasses
- Off-site specialty care
- Medical record management and maintenance
- Title XV Standardization

## Summary

- The Santa Barbara County Public Health Department (PHD) conducts quarterly audits of Wellpath's contracted Service Level Agreements
- Audits include review of medical records and performance measures
- PHD completed a report for audits completed during April 1, 2023 through March 31, 2024
- Measures include timely health assessments, identification and continuation of essential medical medications or psychiatric medications, and providing updated immunizations
- Wellpath staff consistently performed well and PHD calculated the quarterly compliance at a rate of 95% or greater for each quarter during this reporting period
- BWell implemented two new therapeutic approaches including Eye Movement Desensitization and Reprocessing Therapy and Dialectical Behavioral Therapy at both JJC and LPBC
