1. Approve the plans and specifications for the project;
2. Award and execute the construction contract in the amount of \$123,825.00 to the lowest responsible bidder, GPM General Pavement Management, 240 Quail Court, Santa Paula, CA 93060 subject to the provision of documents and certifications, as set forth in the plans and specifications applicable to the project and as required by law.

Summary:

This construction contract is for the grinding and preparation of the existing asphalt concrete pavement within the existing parking lot, placing of a new overlay of asphalt concrete pavement, pavement striping, and other related work as provided for on the plans and specification all within Arroyo Burro Beach County Park.

Background:

Arroyo Burro Beach County Park has suffered from damaged pavement and lack of funding for proper maintenance for many years. This project will reconstruct the parking lot within its existing footprint and provide for the same number of parking stalls, with General Fund Deferred Maintenance Funding allocated in Fiscal Year 2005-06 and Fiscal Year 2006-07.

The low bid was submitted by GPM General Pavement Management of Santa Paula, in the amount of \$123,825.00.
