Adoption of Urgency Ordinance amending Chapter 34A is exempt from California Environmental Quality Act review per CEQA Guidelines Section 15269(c), 15061(b)(3), 15378(b)(5) and 15307 as it is a specific action to mitigate an emergency taken by a regulatory agency for the protection of natural resources to enhance procedures and findings for protection of water resources and does not have the potential for causing a significant effect on the environment.

This urgency ordinance amends Chapter 34A of the County Code in order to implement process changes for water well permitting in accordance with the Governor's Drought Emergency Executive Order N-7-22 issued on March 28, 2022 and which took immediate effect. The urgency ordinance does not relieve a water well applicant's obligation to comply Chapter 34A, California Water Well Standards, or with any sustainable groundwater management program or basin adjudication as established under the authority of the State of California or its Courts. Both the State and County have declared emergencies based on drought conditions.

The exceptions for location, cumulative impact, significant effect, scenic highways, hazardous waste sites, and historical resources, to categorial exemptions contained in Section 15300.2 are not applicable to this action.

#### NOTICE

Each project applicant shall remit to the county clerk the environmental filing fee before or at the time of filing a Notice of Determination (Pub. Resources Code, § 21152; Fish & G. Code, § 711.4, subdivision (d); Cal. Code Regs., tit. 14, § 753.5). Without the appropriate fee, statutory or categorical exemption, or a valid No Effect Determination issued by the California Department of Fish and Wildlife (CDFW), the Notice of Determination is not operative, vested, or final, and shall not be accepted by the county clerk.

#### COUNTY DOCUMENTARY HANDLING FEE

The county clerk may charge a documentary handling fee of fifty dollars (\$50) per filing in addition to the environmental filing fee (Fish & G. Code, § 711.4, subd. (e); Cal. Code Regs., tit. 14, § 753.5, subd. (g)(1)). A county board of supervisors shall have the authority to increase or decrease the fee or charge, that is otherwise authorized to be levied by another provision of law, in the amount reasonably necessary to recover the cost of providing any product or service or the cost of enforcing any regulation for which the fee or charge is levied (Gov. Code, § 54985, subd. (a)).

Within 30 days after the end of each month in which the environmental filing fees are collected, each county shall summarize and record the amount collected on the monthly State of California Form No. CA25 (TC31) and remit the amount collected to the State Treasurer. Identify the remittance on Form No. CA25 as "Environmental Document Filing Fees" per Fish and Game Code section 711.4.

The county clerk shall mail the following documents to CDFW on a monthly basis:

- A list of the name, address and telephone number of all project applicants for which an NOD has been filed. If this information is contained on the cash receipt filed with CDFW under California Code of Regulations, title 14, section 753.5, subdivision (e)(6), no additional information is required.

### **DOCUMENT RETENTION**

The county shall retain two copies of the cash receipt (for lead agency and county clerk) and a copy of all documents described above for at least 12 months.

#### RECEIPT NUMBER

- # The first two digits automatically populate by making the appropriate selection in the County/State Agency of Filing drop down menu.
- The next eight digits automatically populate when a date is entered.
- The last three digits correspond with the sequential order of issuance for each calendar year. For example, the first receipt number issued on January 1 should end in 001. If a county issued 252 receipts for the year ending on December 31, the last receipt number should end in 252.
