Leveraging the resources of several agencies allows for numerous checkpoints and saturation patrols on multiple DUI offenders regardless of jurisdiction. The total value of the grant is \$511,161 and the grant will run through January 31, 2011. This BRR recognizes the financial activity for the fiscal year ending June 30, 2008.
