

**RESOLUTION OF THE BOARD OF SUPERVISORS
COUNTY OF SANTA BARBARA, STATE OF CALIFORNIA**

IN THE MATTER OF APPROVING THE 2026
BOARD OF SUPERVISORS SCHEDULE OF
MEETING DATES AND LOCATIONS

RESOLUTION NO. 25-232

WHEREAS, The location and dates of the Santa Barbara County Board of Supervisors' meetings shall be established, and amended, by Resolution of the Board of Supervisors; and

WHEREAS, The regular meetings of the Santa Barbara County Board of Supervisors shall generally be held on the first three Tuesdays of every calendar month at 9:00 A.M., with the exception of a Tuesday following a Monday holiday; and

WHEREAS, The Board of Supervisors may recess for a consecutive four-week period generally during the last two weeks in July through the first two weeks in August, although the Board may convene during that time, as needed; and

WHEREAS, The 2026 Board of Supervisors Schedule of Meetings include 26 Regular Meetings of the Board of Supervisors as well as Budget Workshops and Budget Hearings. At the discretion of the Board of Supervisors, meetings can be added or cancelled throughout the year as necessary; and

WHEREAS, The 2026 schedule incorporates a Summer Recess from July 21, 2026 through August 11, 2026 and a Winter Recess from December 22, 2026 through January 5, 2027. The proposed recesses maintain two Board of Supervisors meetings a month in July, August and December 2026. The first meeting in 2027 is expected on Tuesday, January 12, 2027, with a second meeting anticipated on Tuesday, January 26, 2027; and

WHEREAS, The members of the Board of Supervisors are also ex officio members of the Boards of a number of Dependent Districts. Dependent Districts may hold hearings at any of the locations and dates identified in the Board of Supervisors Resolution; and

NOW, THEREFORE, BE IT HEREBY ORDERED AND RESOLVED by the Board of Supervisors of the County of Santa Barbara, acting as the governing body of the County of Santa Barbara, approve the 2026 Board of Supervisors Schedule of Meeting Dates and Locations as reflected on page 2 of this Resolution.
