

**AGREEMENT FOR TOBACCO RETAILER LICENSURE PROGRAM**

between

**COUNTY OF SANTA BARBARA**

and

**CITY OF CARPINTERIA**

**FIRST AMENDMENT**

**Effective July 1, 2021**

**THE AGREEMENT** (hereafter Agreement) made by and between the County of Santa Barbara, a political subdivision of the State of California (hereafter COUNTY) and the City of Carpinteria, a municipal corporation in Santa Barbara County (hereafter CITY), collectively referred to as the "Parties" or individually as "Party", effective July 1, 2021 is hereby amended ("First Amendment").

**WHEREAS**, the Agreement is effective through June 30, 2021; and

**WHEREAS**, the parties desire to amend the Agreement to extend the term; and

**WHEREAS**, this First Amendment incorporates the terms and conditions set forth in the Agreement and First Amendment, approved by the County of Santa Barbara.

**NOW, THEREFORE**, in consideration of the mutual covenants and conditions contained herein, the parties agree as follows:

1. **Definitions.** Capitalized terms used in this First Amendment, to the extent not otherwise defined herein shall have the same meanings as in the Agreement.

2. **Amendments.** The Agreement is amended as follows:

a. Agreement Section 2 "Term" is deleted and replaced in its entirety with:

**TERM.** The term of this Agreement shall be from July 1, 2016 through June 30, 2026.

b. Agreement, Section 4 "Designated Representative is deleted and replaced in its entirety with:

**DESIGNATED REPRESENTATIVE.** Joy Kane, Tobacco Prevention Program contact with the Santa Barbara County Public Health Department, at 805-681-5304, is the representative of COUNTY who will administer this Agreement on behalf of COUNTY. Steve Goggia, Community Development Director, at 805-755-4414, is the representative of CITY who will administer this Agreement on behalf of CITY. Changes in designated representatives shall be made only after advance written notice to the other party.

c. Agreement, Section 5 "Notices" is deleted and replaced in its entirety with:

**NOTICES.** Any notice or consent required or permitted to be given under this Agreement shall be given to the respective parties in writing, by first class mail, postage prepaid, delivered as follows:

or at such other address or to such other person that the parties may from time to time designate in writing. Notices and consents under this section, which are sent by mail, shall be deemed to be received five (5) days following their deposit in the U.S. mail.

3. **Ratifications.** The terms and provisions set forth in this First Amendment shall modify and supersede all inconsistent terms and provisions set forth in the Agreement. The terms and provisions of the Agreement, except as expressly modified and superseded by this First Amendment, are ratified and confirmed and shall continue in full force and effect, and shall continue to be legal, valid, binding and enforceable obligations of the parties.
4. **Counterparts.** This First Amendment may be executed in several counterparts, all of which taken together shall constitute a single agreement between the parties.




