**Summary Text:**

Eight bridges, located in the unincorporated areas of Santa Barbara County, received rehabilitation treatments to increase bridge longevity. Work included sealing cracks with Methacrylate Resin, repairing concrete spalls, resurfacing with polyester concrete to repair damaged decks, cleaning and repairing joint seals, and fixing bridge approach paving. Project locations are attached for your information.

The Director of Public Works accepted this project as complete on October 23, 2009. The project was completed on time and on budget.
