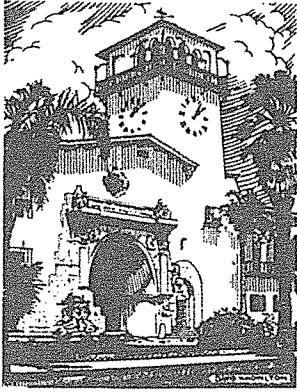


Dear Ms. Leipner:

At the Planning Commission hearing of January 6, 2016, Commissioner Hartmann moved, seconded by Commissioner Brown and carried by a vote of 5 to 0 to:

1. Determine that the proposed Tajiguas Resource Recovery Project, as revised at the hearing of January 6, 2016 to eliminate the proposed placement of temporary operations trailers or other Tajiguas Resource Recovery Project related facilities on the 370 deck in the coastal zone, is in conformity with the Comprehensive Plan; and
2. Transmit the conformity report required by Government Code Section 65402(a) to Joddi Leipner, RRWMD and the Board of Supervisors. The staff report presented to you today and the letter reflecting the Planning Commission's action shall constitute the required report.

The Planning Commission action relative to Government Code Section 65402(a) is advisory in nature; therefore the appeal procedure is not applicable. I am hereby forwarding the Commission's determination to the Board of Supervisors.
