Recommended Actions: Approve and execute a Memorandum of Understanding (MOU) between the County of Santa Barbara, General Services/Communications, and the City of Goleta, to provide the following services to the City: planning, installation, de-installation and repair for City's radio and communications system in return for payment, see exhibit A of MOU.

Summary Text: The City of Goleta wishes to utilize the radio and communications services of the County of Santa Barbara. The City of Goleta is mandated by the State to establish a communications system. This will not only result in potential savings for the City of Goleta, but, moreover, will solidify mutual aid for disaster preparedness between the City of Goleta's and the County of Santa Barbara's Public Works departments.

Background: The City of Goleta and The County of Santa Barbara have an MOU to provide these services that has been in place since June 2006. Approval by the Board of Supervisors will formalize this existing MOU Agreement.

Performance Measure: N/A

<u>Fiscal and Facilities Impacts:</u> This MOU Agreement will provide additional revenue to the County of Santa Barbara. So long as the City of Goleta continues to pay for these services in accordance with the MOU,
