Title: Increase Appropriations to Public Works Guadalupe Flood Zone Fund

Budget Action: Establish appropriations of \$8,000,000 in the PW Guadalupe Flood Zone Fund for Services & Supplies funded by an Operating Transfer from General County

Programs General Fund of \$4,500,000, ARPA Funds of \$2,500,000, and a Release of Restricted Fund Balance in Public Works Guadalupe Flood Zone of \$1,000,000. Increase appropriations of \$4,500,000 in General County Programs General Fund by a release of Unassigned Fund Balance and \$2,500,000 in

County Executive Office COVID-19 General Assistance fund.

Justification: This budget revision is necessary to release \$1,000,000 from Restricted Reserves in Guadalupe Flood Zone and to transfer \$7,000,000 in funds to the

Guadalupe Flood Zone, funded by the General Fund release of Unassigned Fund Balance and ARPA funds to establish a total of \$8,000,000 in the Guadalupe Flood Zone. The funding associated with this action is necessary to re-align the Santa Maria River near the City of Guadalupe to provide

emergency protective measures in the City of Guadalupe and West Main St.
