#### **Recommended Actions:**

That the Board of Supervisors:

- A. Approve plans and specifications for the Construction Ortega Hill Road in Summerland from Route 101 Northbound Ramp to Evans Avenue in the County of Santa Barbara, County Project Number 862118;
- B. Award the construction contract in the amount of \$275,395.50 to the lowest responsible bidder, Nye & Nelson, Inc. (not a local vendor) 1860 Eastman Ave #108 Ventura, CA 93003, subject to the provision of documents and certifications, as set forth in the plans and specifications applicable to the project and as required under California Law;
- C. Authorize the chair to execute the construction contract upon return of the Contractor's executed contract documents and the review and the approval of the County Counsel, Auditor-Controller and Risk Manager or their authorized representatives; and
- D. Approve contingency fund in the amount of \$26,269.78 for the Construction of Ortega Hill Road in Summerland from Route 101 Northbound Ramp to Evans Avenue in the County of Santa Barbara, County Project Number 862118.

Construction of Ortega Hill Road In Summerland From Route 101 Northbound Ramp To Evans Avenue In The County of Santa Barbara; First Supervisorial District; County Project Number 862118

#### **Summary Text:**

On Thursday, September 6, 2007 nine (9) bids were opened for the construction of Ortega Hill Road in Summerland from Route 101 Northbound Ramp to Evans Avenue in the County of Santa Barbara, County Project Number 862118. The lowest responsible bid was submitted by Nye & Nelson, Inc. (not a local vendor), a California Corporation. The lowest responsible bid was submitted in the amount of \$275,395.50, which was 16% under the Engineer's Estimate. The low bid can be attributed to the timing of the project advertisement and the start of construction in October when there are fewer construction projects. Staff has performed an analysis of the bids received and has determined that the low bid is responsive and responsible. Staff recommends awarding this contract to Nye & Nelson, Inc.

This project is located between the North bound US 101 on ramp and Evans Avenue on Ortega Hill Road in the town of Summerland. The purpose of the project is to improve the pedestrian, vehicular and bicycle circulation by constructing curb, gutter and sidewalks, delineating a Class II bike lane and by adding parallel parking. Road access will remain open at all times. The construction work will be limited to one side of the roadway at a time to ensure the least possible disruption to the traveling public. Traffic delays up to 10 minutes can be expected throughout the duration of the project. Construction is currently scheduled to begin October 21, 2007 and to be completed in December, 2007.

This project was bid in accordance with the Public Contract Code, which requires the award to the lowest responsible bidder.

#### **Background:**

On January 3, 2006 the Board of Supervisors approved the project and categorical exemption pursant to the County's Calfornia Environmental Quality Act (CEQA) guidelines and authorized the Director of Public Works to advertise for bids for construction of Ortega Hill Road in Summerland from Route 101 Northbound Ramp to Evans Avenue in the County of Santa Barbara.

This project was included in the FY 05/06 Capital Improvement Program.
