SUBJECT: San Marcos Road Bridge Seismic Retrofit (Br. No. 51C-002); Second Supervisorial District; County Project No. 862037

Recommendation(s):

That the Board of Supervisors:

- A. Approve the Project and Notice of Exemption pursuant to the County's California Environmental Quality Act (CEQA) guidelines for the seismic retrofit of the San Marcos Road Bridge at Maria Ygnacia Creek (Br. No. 51C-002), Project No. 862037;
- B. Authorize the Director of Public Works to advertise for construction bids for the San Marcos Road Bridge Seismic Retrofit Project.

Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with Goal No. 1. An Efficient Government Able to Respond Effectively to the Needs of the Community.

Executive Summary and Discussion:

The proposed project is located on San Marcos Road, Bridge 51C-002 over Maria Ygnacia Creek near the City of Goleta, California.

The proposed project will consist of seismically retrofitting the existing bridge. The retrofit will strengthen the existing bents by adding new steel bracing members. In addition to the strengthening of the bents, the abutments will also have steel rods installed to limit the longitudinal movement of the bridge.



Pursuant to the County's CEQA guidelines, the project has been determined to be exempt from further environmental review. Approval of the Notice of Exemption shall indicate the Board of Supervisors' approval of the project and will commence the appeal period, pursuant to CEQA guidelines.

Sealed proposals will be received at the Public Works front counter in the County Engineering Building, 123 E. Anapamu Street, Santa Barbara, California 93101, and will be opened and publicity read aloud at a date to be determined.

The "Notice to Contractors" will be published prior to the date set for the opening of bids.

This project was approved as a part of the FY 02/03 Capital Improvement Plan.

Mandates and Service Levels:

Approval by the Board of Supervisors will not change the programs or service levels.

Fiscal and Facilities Impacts:

There will be no fiscal impact with this action. The Federal Highway Bridge Rehabilitation and Replacement Program (HBRRP) will fund 100% of the project.
