## **Recommendation(s):**

That the Board of Supervisors:

Set a hearing for February 7, 2005 to receive the Tobacco Settlement Advisory Committee (TSAC) funding recommendations for FY 2006-2007, adopt changes to TSAC membership, establish term limits, and receive a follow up report on TSAC in response to the 2004-05 Santa Barbara County Civil Grand Jury.

**Executive Summary and Discussion:** On January 25, 2000, the Board created the Tobacco Settlement Advisory Committee (TSAC), and directed the Committee to present its recommended allocations to the Board of Supervisors every January for the subsequent fiscal year. These funds were directed by the Board to be used for county health needs and programs.

The 2004-05 Santa Barbara County Civil Grand Jury report on the TSAC included recommendations on changes to membership and term limits. TSAC has considered these recommendations and will put forward changes for adoption by the Board.

In June of 2005, the Board adopted the Public Health Department's responses to findings and recommendations in the 2004-05 Grand Jury Report on TSAC. Three of these recommendations required further study and analysis. This work has been completed and the Board is requested to receive the follow-up report that addresses these items.

Mandates and Service Levels: Setting a hearing will not result in any change in mandates or services levels.
