- b) Authorize the Director of General Services to act as agent on behalf of the County of Santa Barbara pertaining to the acceptance of the Grant Allocation and the Grant Agreement.

## **Executive Summary and Discussion:**

Due to necessary updating and on going wear and tear, this work has been proposed by the Airport Authority in order to properly maintain the airport. (See previous memo to the Board regarding the relationship between the County and the Authority.). This proposed project consists of East Apron Reconstruction, Access Road and Parking Reconstruction, and Infield Drainage Improvements. Activities include the removal and reconstruction of existing asphalt pavement surfaces, pavement pulverizing, subgrade preparation, installation of aggregate base and asphalt pavement, construction of concrete valley gutters, installation of storm drainage, modifications to existing storm drain inlets and outlets, installation of aircraft tie-downs, and installation of pavement markings.

## **Mandates and Service Levels:**

Direction by the Board of Supervisors will not change the programs or service levels.

## **Fiscal and Facilities Impacts:**

Funding for this project is provided by three separate grants from the Federal Aviation Administration (FAA), State matches from the California Department of Transportation, Aeronautics Program and a small local match from the Santa Ynez Airport Authority. Ninety-five percent (95%) or, Eight Hundred and Eighteen Thousand Eight Hundred and Two Dollars (\$818,802.00) is funded by the FAA. The State of California-Department of Transportation-Aeronautics Program State Matching Grant is 4.8% or Forty Thousand Nine Hundred and Forty Dollars and Ten Cents (\$40,940.10). The Santa Ynez Valley Airport Authority is paying the local share of .2% or Two Thousand One Hundred and Fifty-Four Dollars and Seventy-Four Cents (\$2,154.74).
