- B. Review and approve the Statement of Final Quantities for work performed, and materials supplied for this project by the Contractor, in the amount of \$1,293,206.67.

Summary Text:

This project resurfaced a total of 7.6 lane miles of roads. Construction included repairs of failed pavement areas, placement of a Type-B asphalt concrete overlay over Stress Absorbing Membrane Interlayer (SAMI), asphalt concrete leveling course, and a conventional overlay utilizing reinforcement fabric. The project was accepted as complete by the Director of Public Works on November 25, 2009. The completion of the project was delayed due to the need to raise a utility manhole on Calle Real; however, it was completed within the allotted budget.

Background:

On February 17, 2009, the Board of Supervisors authorized the Director of Public Works to advertise for construction bids for the 2009 American Recovery and Reinvestment Act (ARRA), and approved the CEQA Notice of Exemptions and road rehabilitation locations. This project received the Authority for Construction approval from Caltrans on May 5, 2009. The project was awarded by the Board of Supervisors on June 23, 2009, to repair failed pavement areas and place a Type-B Asphalt Concrete Overlay over a Stress Absorbing Membrane Interlayer (SAMI), and asphalt concrete leveling course.
