**WHEREAS**, the Board of Supervisors on July 6, 2010 adopted Resolution No. 10-188, on August 19, 1974 adopted Resolution No. 74-649, on June 5, 1990 adopted Resolution No. 90-326, on September 16, 2003 adopted Resolution No. 03-280, which established various parking restrictions in the Isla Vista area,

**WHEREAS**, conditions have changed since these Resolutions were adopted and it is now in the best interest of the public to revise these parking restrictions.

**NOW THEREFORE, IT IS HEREBY RESOLVED AND ORDERED**, that Resolution 10-188 which established Time Limited Parking on Embarcadero Del Norte, Resolution 74-649 that established No Parking on Del Playa Drive, Resolution No 90-326 that established No Parking on Camino Del Sur, and portions of Resolution 03-280 which established No Parking on Sabado Tarde Road are rescinded at the following locations:

Time Limited Parking Zone (15 Minute Parking, 9:00 am to 6:00 pm, excluding Sundays and holidays)

- Resolution 10-188 -On the west side of Embarcadero Del Norte between a point 67 feet south of the centerline of Pardall Road and a point 117 feet south of the centerline of Pardall Road.

No Parking Zones

- Resolution 74-649 - On the south side of Del Playa Drive between 179 feet east of the centerline of Camino Del Sur and 143 feet east of the centerline of Camino Del Sur.
- Resolution 90-326 - On the west side of Camino Del Sur between a point 60 feet south of the centerline of Estero Road and a point 70 feet north of the centerline of Estero Road.
- Resolution 90-326 - On the east side of Camino Del Sur between a point 90 feet south of the centerline of Estero Road and a point 20 feet north of the centerline of Estero Road.
- Resolution 03-280 - On the south side of Sabado Tarde Road between the centerline of Camino Del Sur and a point 82 feet east of the centerline of Camino Del Sur.
- Resolution 03-280 - On the south side of Sabado Tarde Road between the centerline of Camino Pescadero and a point 73 feet east of the centerline of Camino Pescadero.

**IT IS FURTHER RESOLVED** that the Santa Barbara County Director of Public Works or designee is hereby authorized and directed to remove appropriate markings and/or signs at said locations as time and resources permit.
