SUBJECT: No Parking and Limited (20 minute) Parking Zones on Foster Road and Bradley Road

in the Fourth Supervisorial District.

RECOMMENDATIONS:

C.A. Recommendation:

That the Board of Supervisors:

- A. Rescind Resolution Nos. 69-639 and 69-640, which established no parking and passenger loading zones on Foster Road, and a no parking zone on Bradley Road.
- B. Adopt a resolution establishing updated no parking and limited parking zones on Foster Road in the Orcutt area.

ALIGNMENT WITH BOARD STRATEGIC PLAN:

The recommendations are primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure.

EXECUTIVE SUMMARY & DISCUSSION:

Bradley Road is an arterial road in the Orcutt area and contains bike lanes; therefore the Resolution No. 69-640 designating a no parking zone on Bradley Road north of Foster Road is not needed any more and should be rescinded.

Foster Road is a collector road in the Orcutt area. Righetti High School is located on the north side of Foster Road west of Bradley Road. Currently, there is a no parking zone on the south side of Foster Road across from Righetti High School. There are also several loading and no parking zones on the north side of Foster Road in front of the high school. After meeting with the principal of Righetti High School and the Fourth District Supervisor, it was decided by the Public Works

Department to update these zones by removing portions of the no parking zones and changing the loading zones to limited (20 minute) parking zones.

The Public Works Traffic Section has prepared the attached resolutions to rescind the old resolutions and establish new no parking and limited parking zones at the following locations:

NO PARKING ZONES

On the north side of Foster Road between the centerline of Bradley Road and a point 290 feet west of the centerline of Bradley Road.

On the north side of Foster Road between a point 425 feet west of the centerline of Bradley Road and a point 526 feet west of the centerline of Bradley Road.

On the north side of Foster Road between a point 566 feet west of the centerline of Bradley Road and a point 683 feet west of the centerline of Bradley Road.

On the north side of Foster Road between a point 914 feet west of the centerline of Bradley Road and a point 1012 feet west of the centerline of Bradley Road.

On the north side of Foster Road between a point 1214 feet west of the centerline of Bradley Road and a point 1318 feet west of the centerline of Bradley Road.

On the south side of Foster Road between the centerline of Bradley Road and a point 447 feet west of the centerline of Bradley Road.

On the south side of Foster Road between a point 586 feet west of the centerline of Bradley Road and a point 751 feet west of the centerline of Bradley Road.

On the south side of Foster Road between a point 909 feet west of the centerline of Bradley Road and a point 1079 feet west of the centerline of Bradley Road.

LIMITED (20 MINUTE) PARKING ZONES

On the north side of Foster Road between a point 526 feet west of the centerline of Bradley Road and a point 566 feet west of the centerline of Bradley Road.

On the north side of Foster Road between a point 683 feet west of the centerline of Bradley Road and a point 914 feet west of the centerline of Bradley Road.

On the north side of Foster Road between a point 1012 feet west of the centerline of Bradley Road and a point 1214 feet west of the centerline of Bradley Road.
