# **Summary Text:**

This item is on the agenda to approve the appointment of Jesus Armas as Santa Barbara County's Community Services Department Director as of January 22, 2024, following the retirement of Director George Chapjian, who is retiring from the position in January 2024. Mr. Armas was selected following a nationwide recruitment process.

#### **Background:**

Mr. Armas has extensive leadership experience spanning a thirty-year tenure in the public and private sectors. His twenty-year service to two Bay Area cities as a City Manager was distinguished by strategic leadership, where he fostered a collaborative and mission-driven work environment overseeing a staff of 1,000 ensuring services were delivered in an efficient and cost-effective manner.

As Executive Director of the Hayward Redevelopment Agency, Mr. Armas was responsible for a project area encompassing 1,500 acres, with an assessed valuation of \$1.5 billion. Under his leadership, a downtown characterized by vacant properties was transformed into a vibrant, mixed-use, transit-oriented development anchored by new retail establishments and over 1000 new residential units, all within walking distance of a Downtown Intermodal Center.

Mr. Armas has extensive experience collaborating with non-profit organizations to provide community-based social services and facilitating the delivery of affordable housing and shelter projects. As an elected school board member, he successfully spearheaded campaigns to gain voter approval of a \$200 million bond measure and parcel tax.

Mr. Armas will relieve Director George Chapjian upon his retirement, who's accomplished 8.5 years of service is highlighted by championing efforts to bring Community Choice Energy to our region and establishing the Tri-County Regional Energy Network; increasing access to outdoor parks and recreation opportunities; and bringing unprecedented levels of Federal, State and local funding to address the homelessness and affordable housing crisis.
