That the Board of Supervisors adopt a resolution establishing a "No Parking" zone on Hummel Drive, in the Orcutt area.

ALIGNMENT WITH BOARD STRATEGIC PLAN:

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure.

EXECUTIVE SUMMARY & DISCUSSION:

Hummel Drive is a minor collector road that extends southward from Foster Road.

A request was received from a concerned citizen asking for a "No Parking" zone on the west side of Hummel Drive to provide for the safety of vehicles entering and exiting the Mariposa Town homes onto Hummel Drive. Based upon our investigation of this site, it was determined that creating a "No Parking" zone at this location (see vicinity map), would create a safer environment when using the business entrance and for motorists driving on Hummel Drive. The Public Works Traffic Section has prepared the attached resolution to establish a "No Parking" zone at the following location:

On the west side of Hummel Drive from a point 843 feet south of the centerline of Union Valley Parkway to a point 1,141 feet south of the centerline of Union Valley Parkway in the Orcutt area.
