During the budget process earlier this year, the Board approved the addition of a Communications Director. This recommendation establishes the at-will, assistant department head classification and allocates the position. The Communications Director is responsible for planning, coordinating, and disseminating a professional media and community relations strategy, and for ensuring that all appropriate constituencies are adequately informed of County activities and services. The position will report to an Assistant County Executive Officer in the County Executive Office.
