SUBJECT: Resolution Adopting Updates to the Multihazard Functional Plan

Recommendation(s):

That the Board of Supervisors adopt the resolution confirming changes to the Multihazard Functional Plan for all risk emergencies.

Alignment with Board Strategic Plan:

The recommendation is primarily aligned with Goal No. 1. An Efficient Government Able to Respond Effectively to the Needs of the Community.

Executive Summary and Discussion:

The Santa Barbara County Code (Chapter 12, Section 8) mandates that the Santa Barbara County Disaster Council shall develop an emergency plan for the County. On February 13, 1989, the Board of Supervisors adopted the County's Multihazard Functional Plan which provides the operational guidance for the County's response to all risk disasters (e.g., fires, floods, earthquakes, etc.).

On November 7, 1995 your Board passed Resolution 95-496 that authorizes the Director of Emergency Services for the County of Santa Barbara (the County Administrator) to make administrative changes and updates to this plan, then return to the Board at the next regular meeting for confirmation of those changes. Those changes are limited to:

- Revising functional responsibilities of positions identified in the plan
- Updating phone numbers and name changes, and

• Updating the County Emergency Management Organization and Emergency Operations Center (EOC) to meet the requirements of the State's Standardized Emergency Management System (SEMS).

The current revisions of the Multihazard Functional Plan presented for your Board's confirmation include the following:

- *Name change to Plan:* From Multihazard Functional Plan to "Standardized Emergency Management System Multi-Hazard Functional Plan (SEMS MHFP).
- *Removal of Annexes:* To keep compliant with State Emergency Plan and the Standardized Emergency Management System Government Code Section 8607(a), the annexes in the SEMS MHFP have been removed and the plan is now defined as follows:
 - Part One Basic Plan. Overall organizational and operational concepts relative to response and recovery, as well as an overview of potential hazards. Intended audience Emergency Operations Center (EOC) Management Team.
 - Part Two Emergency Organization Functions. Description of the emergency response organization and emergency action checklists in accordance with SEMS. Intended audience EOC staff.
 - Part Three Supporting and legal documents to the Standardized Emergency Management System (SEMS) Multi-Hazard Functional Plan (MHFP). Intended audience all elements of the SEMS staff.

Mandates and Service Levels:

No change in programs or service levels.

Fiscal and Facilities Impacts:

Emergency planning activities are funded in the Office of Emergency Services budget (Program – Administration 6010, Emergency Management Planning 6042; Organization Unit 4000; Project – partially funded by EMA 4410 and General Fund).
