# Summary Text:

The SBFA has presented to the fire department, 250 safety goggles that will give firefighters additional eye protection while fighting wild fires. With the purchase of the 250 goggles, department members will be able to have superior eye protection during "firestorm" type environments. These goggles have been found to far exceed the protection of our currently issued goggles.

The SBFA has also presented to the fire department one slip-on fire pump to be carried on the Hand Crew vehicle. The crew primarily fights fire with hand tools in remote areas in the county. This pump will assist the crew with firefighting by having a small supply of water on hand with a pump to keep a small fire from becoming a large one or assist with mop up where hand tools will not work.
