

**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE
COUNTY OF SANTA BARBARA, STATE OF CALIFORNIA**

**IN THE MATTER OF ESTABLISHING)
PARKING RESTRICTIONS)
ON VARIOUS COUNTY ROADS) RESOLUTION NO. _____
IN THE SECOND, THIRD AND FOURTH)
SUPERVISORIAL DISTRICTS)**

WHEREAS, California Vehicle Code Section 22507 and the Code of Santa Barbara County, California, Section 23-11, authorize the Board of Supervisors of the County, to establish parking regulations on portions of roads and highways under its jurisdiction; and

WHEREAS, it is in the best interest of public safety that certain portions of County highways in Santa Barbara County be designated with no stopping, standing, or parking of vehicles, in accordance with said Sections:

NOW THEREFORE, IT IS HEREBY RESOLVED AND ORDERED, that the following locations in Santa Barbara County and under the jurisdiction of the Board of Supervisors of said County are hereby designated as no stopping, standing, or parking zones and that the Director of Public Works of the County of Santa Barbara is hereby authorized and directed to install and maintain appropriate pavement markings and signs at the following locations.

No Stopping, Standing, or Parking Zones

- On the north side of Cathedral Oaks Road from to a point 270 feet west of the centerline of State Route 154 southbound off ramp to the centerline of Turnpike Road.
- On the south side of Cathedral Oaks Road from the centerline of Turnpike Road to a point 45 feet east of the centerline of El Sueno Road.
- On the south side of Cathedral Oaks Road from a point 200 feet east of the centerline of El Sueno Road to the centerline of Lorraine Avenue.
- On both sides of Via Chaparral from the centerline of Cathedral Oaks Road to the centerline of La Paloma Avenue.
- On the north side of Burton Mesa Boulevard from a point 160 feet west of the centerline of Constellation Road to a point 282 feet west of the centerline of Constellation Road.
- On the north side of Burton Mesa Boulevard from a point 408 feet west of the centerline of Constellation Road to a point 563 feet west of the centerline of Constellation Road.
- On the north side of Burton Mesa Boulevard from a point 668 feet west of the centerline of Constellation Road to a point 824 feet west of the centerline of Constellation Road.
- On the west side of Bradley Road from the centerline of Amethyst Drive to a point 120 feet south of the centerline of Amethyst Drive.
- On the west side of Bradley Road from the centerline of Basque Drive to a point 80 feet south of the centerline of Basque Drive.
- On the north side of Hollysprings Lane from the centerline of Harp Road to its easterly terminus.
- On the south side of Hollysprings Lane from its easterly terminus to a point 90 feet west of its easterly terminus

- On the west and north side of Cosima Lane from the centerline of Hollysprings Lane to its westerly terminus.
- On the south side of Cosima Lane from its westerly terminus to a point 90 feet east of its westerly terminus.

3 Minute Passenger Loading Zone (7:00 am to 4:00 pm school days only)

- On the west side of Ribera Drive from a point 72 feet south of the centerline Walnut Park Drive to a point 272 feet south of the centerline Walnut Park Drive.

No Parking 8:00 pm to 6:00 am

- On both side of Camino Del Rio from the centerline of Cathedral Oaks Road to the centerline of Camino Molinero.
- On the west side of Camino Del Retiro from the centerline of Cathedral Oaks Road to a point 645 feet north of the centerline of Cathedral Oaks Road.

IT IS FURTHER RESOLVED that the Santa Barbara County Director of Public Works or designee is hereby authorized and directed to install appropriate markings and/or signs at said locations as time and resources permit.
