

FIRST AMENDMENT TO AGREEMENT FOR PROFESSIONAL LEGAL SERVICES

This First Amendment to the Agreement for Professional Legal Services ("AGREEMENT") is made by and between the County of Santa Barbara ("COUNTY") and Wilmer Cutler Pickering Hale & Dorr LLP ("ATTORNEY"), wherein ATTORNEY agrees to provide and COUNTY agrees to accept the services specified herein.

WHEREAS, the COUNTY continues to require the services of legal counsel to assist in providing legal advice and representation in the specialized area of environmental law and compliance matters; and

WHEREAS, Paragraph 26 of the AGREEMENT states the AGREEMENT may be altered, amended or modified by an instrument in writing, executed by the Parties; and

WHEREAS, the COUNTY wishes to increase the maximum contract amount by Two Hundred Thousand Dollars (\$200,000).

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, the parties agree as follows:

The Parties agree to amend the AGREEMENT as follows:

1. Exhibit B, Paragraph A is revised to state:

For ATTORNEY services to be rendered under this AGREEMENT, ATTORNEY shall be paid the hourly rates defined in Attachment B-1 for a total contract amount, including cost reimbursements, up to but not to exceed \$650,000.

2. In all other respects, the AGREEMENT remains unchanged and in full effect.
