#### **Recommendation(s):**

That the Board of Supervisors:

Reject all bids for the Construction of 2003/2004 County Wide Measure 'D' Preventive Maintenance Application of Asphalt Rubber Seal Coat and Slurry Seal, County Project No. 820501 pursuant to Article 25, Section 20395 of the California Public Contract Code:

#### **Alignment with Board Strategic Plan:**

The recommendation(s) are primarily aligned with Goal No. 1, An Efficient Government Able to Respond Effectively to the Needs of the Community.

### **Executive Summary and Discussion:**

On Thursday, July 15, 2004, two (2) bids were opened for the Construction of 2003/2004 County Wide Measure 'D' Preventive Maintenance Application of Asphalt Rubber Seal Coat and Slurry Seal, County Project No. 820501. Manhole Adjusting Contractors, Inc. (Not a Local Vendor) submitted the lowest responsible bid in the amount of \$711,728.20, which was 30% above the Engineer's Estimate.

Staff has performed an analysis of the bids received and has determined that the costs were too high and exceed the approved funding allotment for this project in the amount of \$162,479.20. It has been reported that the sharp increase in cost of materials (oil/rubber), transportation, insurance and workers compensation in California this year have contributed to the increased expense of performing work of this type.

This project would have consisted of the placement of ARAM (Asphalt Rubber Aggregate Membrane) on rural roads with the addition of a slurry seal on urban roads, known in the construction industry as a Cape Seal. The utilization of ARAM as a re-surfacing strategy was a pilot program approved by your board as part of the FY 2003/2004 Capital Improvement Plan. The specific project locations were approved by your Board in the FY 2003/2004 Road Maintenance Annual Plan (RdMap) and are attached for your information. Approximately 12 lane miles of County maintained roadway were to be resurfaced as a result of this project.

The Department recommends rejecting both bids for this project in accordance with Article 25, Section 20393 of the California Public Contract Code. The Department will review its options regarding the pavement management strategy to be utilized for the streets and roads included in this project.
