There was a meeting in 2018 where my architect had apparently made an agreement with Alex Pujo that we would agree to everything he said plus make a payment of \$1000 under the table. I fired my architect at the end of that meeting. It was obvious that something was up, that I was not a party too.

Recently, the department of Planning and Development of Extortion and Corruption cancelled the bill.
