FIRST AMENDMENT

This First Amendment (hereafter referred to as "First Amendment") to the Agreement for Software License Support and Maintenance, BC 19-085 (hereafter Agreement), by and between the County of Santa Barbara (County) and AutoMon, LLC (Contractor), is entered into for the purpose of exercising the first of two (2) options to extend the term of the Agreement an additional four (4) years pursuant to Section 4 of the Agreement.

WHEREAS, County and Contractor agree to extend the term of the Agreement an additional four (4) years following the termination of the initial term on May 31, 2022;

WHEREAS, County and Contractor agree to an additional payment to Contractor of \$864,150 for services rendered during the four (4) year period commencing June 1, 2022 and ending May 31, 2026, thus increasing the total contract maximum amount not to exceed \$1,406,057.55.

NOW, THEREFORE, this Agreement is amended as follows:

I. Attachment B-1, "SCHEDULE OF FEES", to Exhibit B of the Agreement, is amended to include the Option 1 Pricing as follows:
