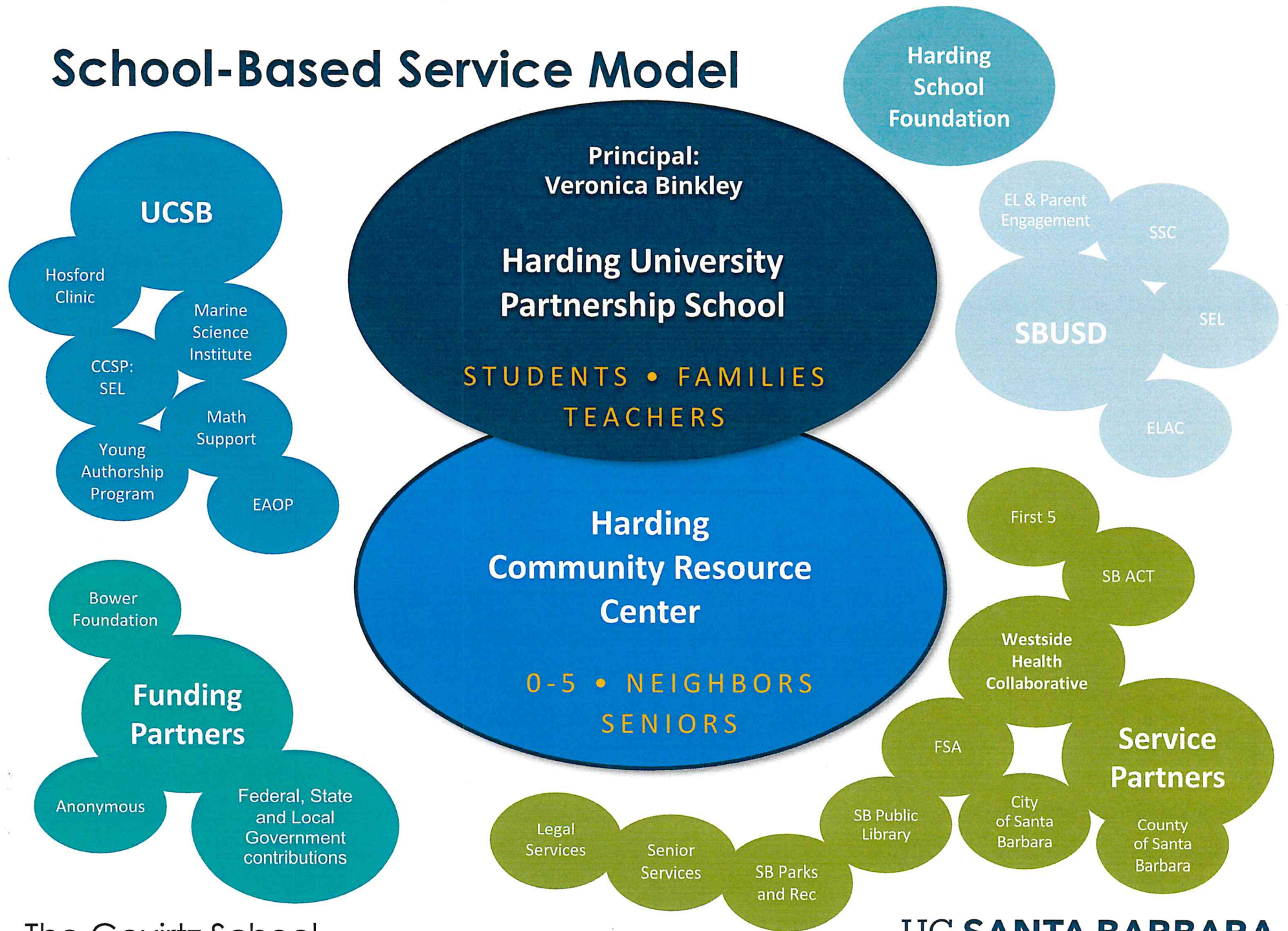

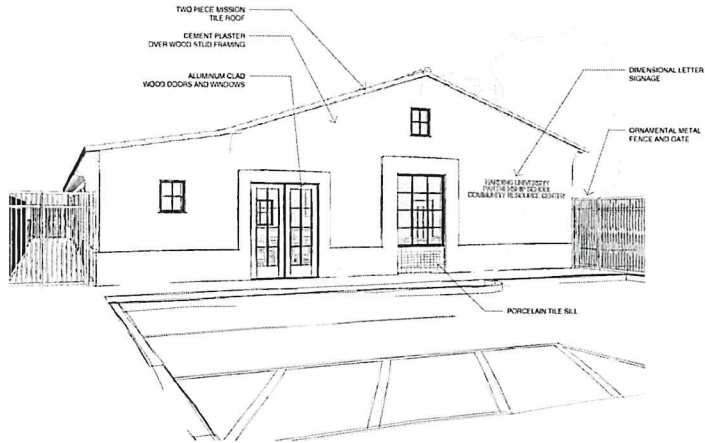

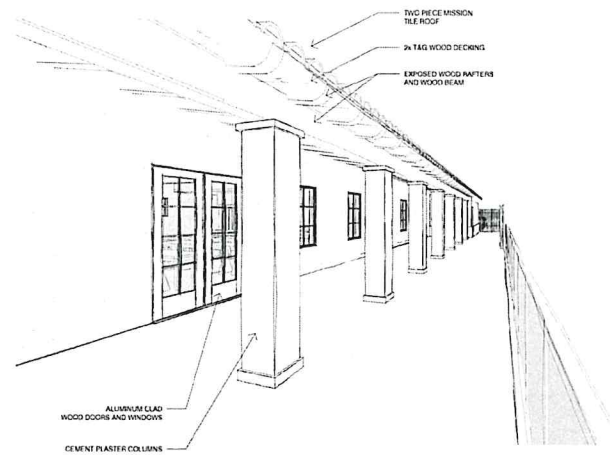


## Current structure (Gillespie Street view)

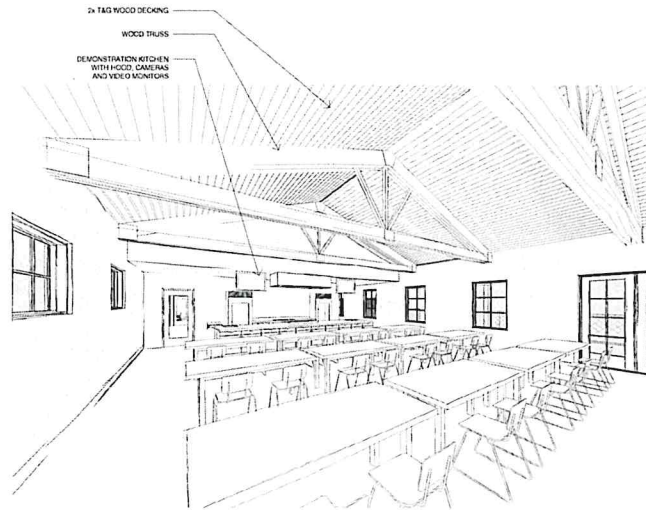




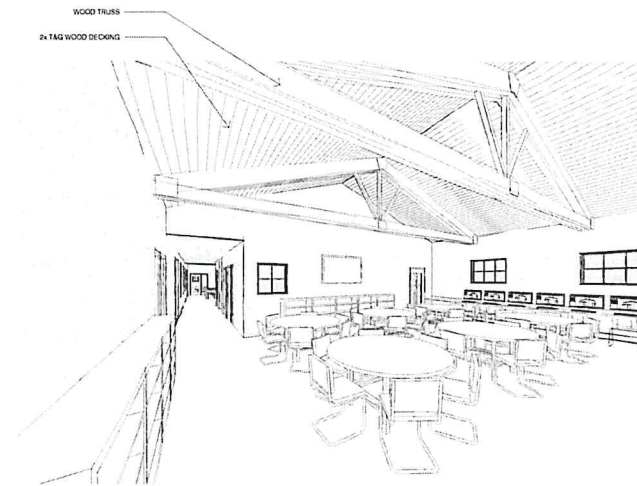

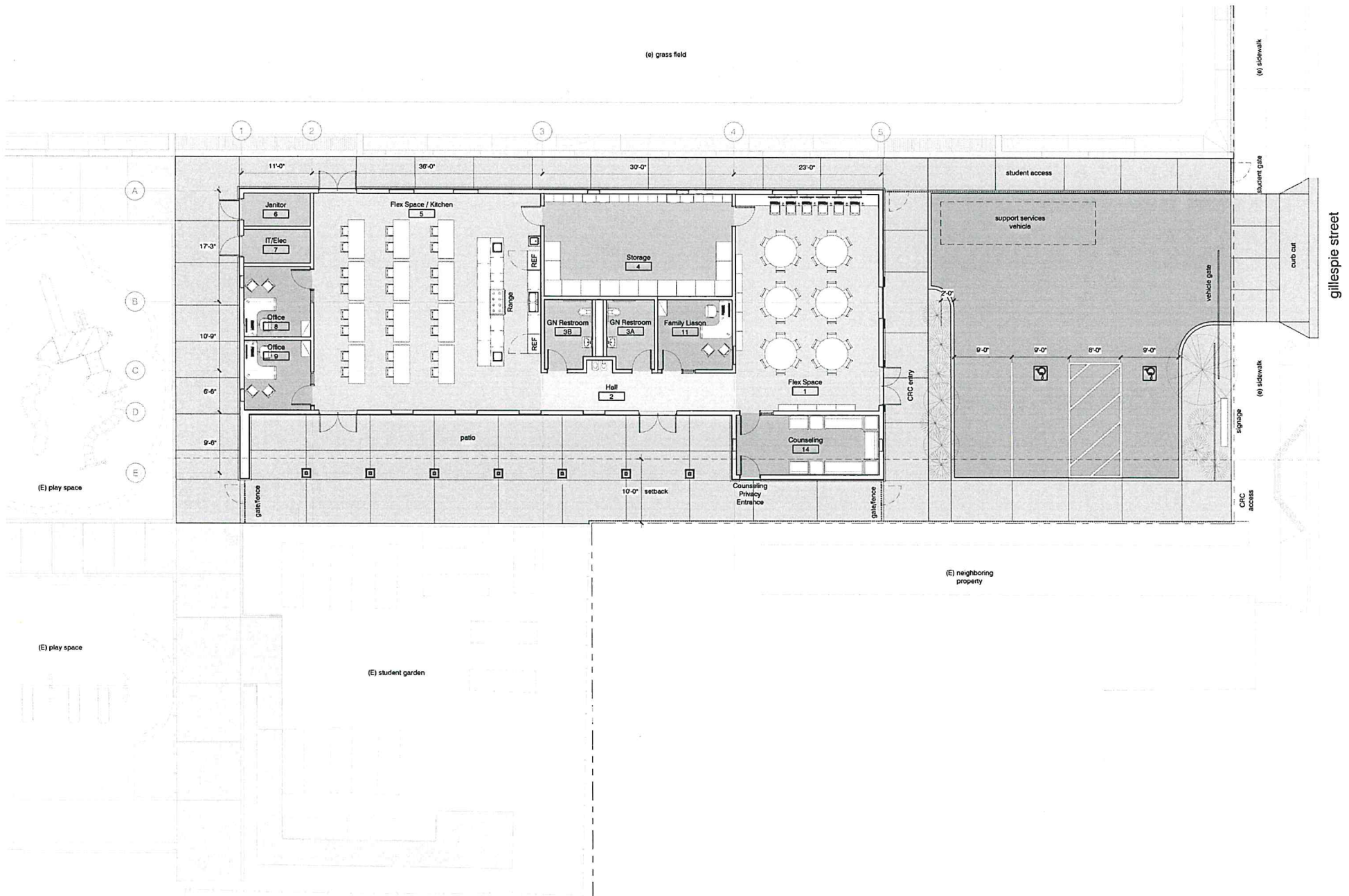

# Project Plan

## PRESENT CONCEPT & DEVELOP PARTNERSHIPS

With approval from the SB Unified School District and the City of Santa Barbara, the Gevirtz School takes a leadership role in developing and coordinating partnerships.

After formal presentations, the project has been approved by the SBUSD School Board and the Santa Barbara City Council.

## COMMUNITY NEEDS ASSESSMENT

As an extension of Cottage Population Health's [Community Health Needs Assessment](#), the Gevirtz School and the Center for Evaluation & Assessment assisted with focused surveys and interviews to identify needs and opportunities in the community. A formal report was completed in 2022.

This report also establishes a baseline which will help researchers to evaluate the impacts of the Center.

## DESIGN & PERMITS

SBUSD and GGSE have worked with KBZ Architects to complete initial plans for the building. Plans will be permitted by the the Division of State Architects (DSA) once project funding has been secured.

## CONSTRUCTION

During construction, the Gevirtz School, SBUSD, and community partners will collaborate to develop programming and to formalize plans for using and scheduling the new Center.

Many supports and programs are already or will be in place prior to the completion of the building.
