#### **Executive Summary and Discussion:**

## Hospital Advisory Boards, State Department of Mental Health

The Governor selects appointees from nominations submitted by the Board of Supervisors from counties within each State Hospital's designated service area. Napa State Hospital service Northern and Central California which includes the Santa Barbara County geographic area.

Linda Hatch, Ph.D. currently works for Alcohol, Drug and Mental Health Services in our Multi-Agency Integrated System of Care at the Santa Barbara Children's Clinic. Dr. Hatch has, in the past, worked in a state hospital as a staff psychologist, has done forensic assessment work with State Hospital patients, such as Mentally Disordered Offender evaluations for the Parole Board, at Atascadero State Hospital, and Sexually Violent Predator assessments for the California State Department of Mental Health.

Her background enables her to provide the State Department of Mental Health and the Legislature with appropriate advise in respect to the conduct of hospitals and coordination with community mental health programs.

The Hospital Advisory Board is charged with ensuring through partnerships the availability and accessibility of effective, efficient, culturally competent services through advocacy, education, oversight, monitoring, quality improvement, and the provision of direct services.

The Department supports Dr. Hatch's nomination for this position of Advisory Board Member. Her position as an Advisory Board Member will provide the Department with unique insight into the development of State Hospital policies, as well as maintaining appropriate services for persons in State Hospitals.
