Review and approve the Statement of Final Quantities for work performed and materials supplied for this project by the Contractor, Security Paving Company, Inc. (not a local vendor), Post Office Box 1489, Sun Valley, California 91353, in the amount of \$1,967,729.94.

Alignment with Board Strategic Plan:

The recommendation is primarily aligned with Goal No. 1, An Efficient Government Able to Anticipate and Respond Effectively to the Needs of the Community.

Executive Summary and Discussion:

This project is one of the strategies that the Department employs as part of the County's Preventative Maintenance Program. Your Board approved this contract as part of the FY 2000/2001 Road Maintenance Annual Plan. Security Paving Company, Inc. (not a local vendor) was awarded this contract in the amount of \$1,978,204.25 on April 16, 2002.

This project consisted of the removal and repair of failed areas and cold planing of the existing pavement, placing pavement reinforcing fabric and placement of a Type B asphalt concrete overlay over an asphalt concrete leveling course. Approximately 31 lane miles of County maintained roadway was resurfaced with the construction of this project.

The contract was accepted on October 24, 2002, by the Director of Public Works as complete. The project was completed on time and within the original budgeted contract amount.
