#### **Recommended Actions:**

Set a hearing for November 8, 2011 to consider an Appeal (Case No. 11APL-00000-00010) of the Planning Commission's decision to approve a Revision to the Diamond Rock Mine Conditional Use Permit (Case No. 11RVP-00000-00032). The subject site is Assessor Parcel Nos. 149-220-002, located on the West side of Highway 33 approximately 5.9 miles south of its junction with Highway 166 in the Cuyama/Ventucopa area, First Supervisorial District. At the November 8, 2011 hearing, the Board of Supervisors action should include the following:

- 1. Make the required findings for approval of Case No. 11RVP-00000-00032, including the CEQA findings;
- 2. Adopt the Addendum to Environmental Impact Report 05EIR-00000-00001 pursuant to Section 15164 of the State Guidelines for Implementation of the California Environmental Quality Act;
- 3. Deny the Appeal, Case No. 11APL-00000-00010, thereby upholding the County Planning Commission's approval of 11RVP-00000-00032; and
- 4. Grant *de novo* approval of Case No. 11RVP-00000-00032 subject to the Conditions of Approval in Attachment 4.
