

# Jail Population Management Plan and Status Update

Board of Supervisors Meeting  
January 23, 2024

# Background

- Collaborative efforts in recent years by criminal justice (CJ) partners have focused on reducing recidivism, diverting from jail individuals with behavioral health needs, and improving speed and efficiency of the justice system.
- In July 2022, MW Consulting provided initial report, which analyzed criminal justice trends, projected the long-term jail population, and explored policy options to reduce the jail population.
  - Long-term projection was 800-900 beds, which could be reduced through "policy levers" related to expanding diversion, expanding electronic monitoring, reducing recidivism, etc.
- CJ partners were simultaneously working on multiple related initiatives, e.g., expanding pretrial services, holistic defense, diversion programs, etc.

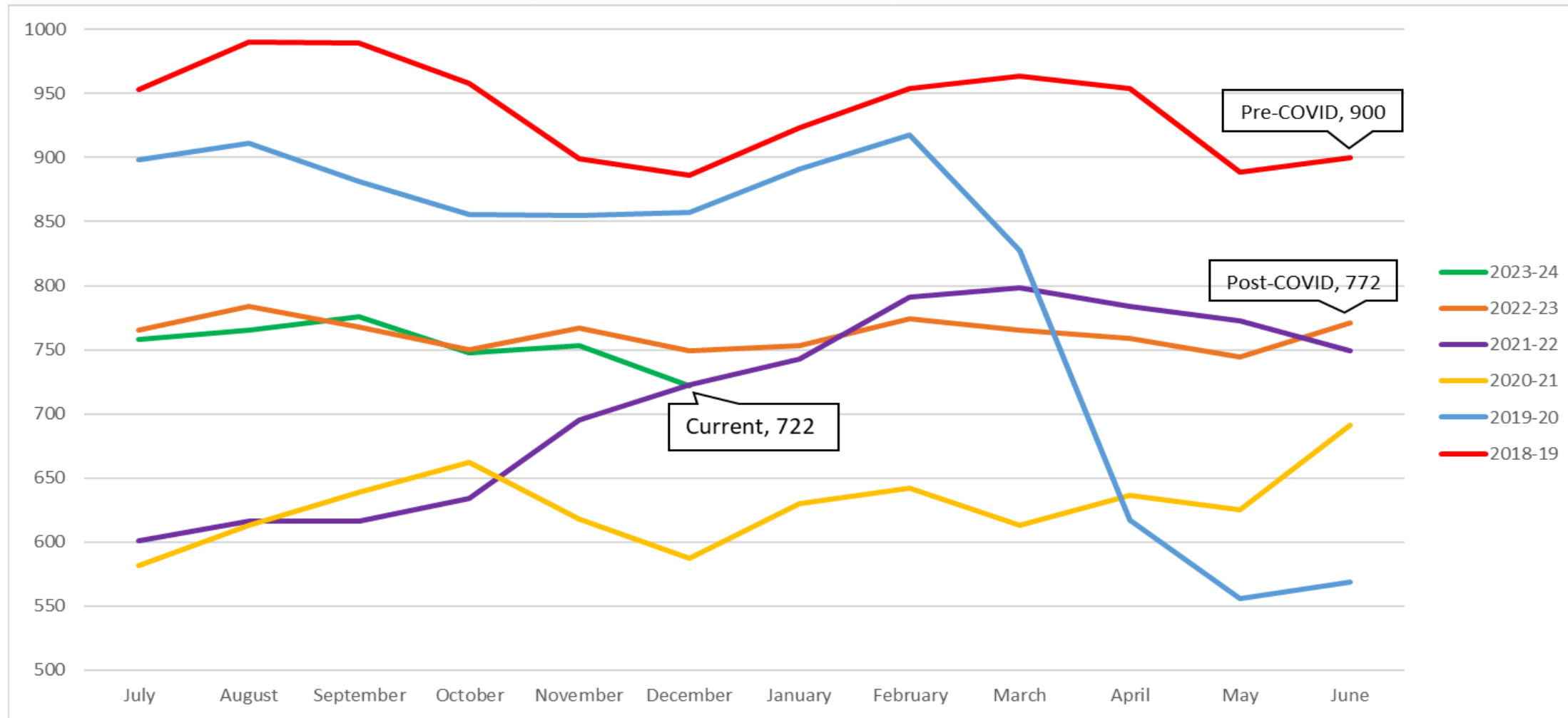
# Key Takeaways – MW Consulting Report

- SBC incarceration rate is higher than State's.
- Previous factors of concern (e.g., NBJ opening) have not proven to increase jail population.
- Population adjustment has been made and Alternative Sentencing data has been incorporated. Current projection is 700-800 as incarceration numbers have not returned to pre-pandemic levels.
- Further reduction is achievable through targeted measures.
  - Based on recent data from the jail, further reduction of the population suffering from mental health issues should continue to be a priority.

# Jail Population Management Plan

- In May 2023, Board directed staff to obtain designs for new construction of one pod at the Northern Branch Jail (NBJ) for a total jail system capacity of 728 beds, and to return with targeted diversion strategies to address jail population management
- Additionally, written update of jail population management initiatives is required to comply with Stipulated Judgment in *Murray et al. v. County et al.*
- Attached report is in response to both Board direction and Stipulated Judgment requirements
- Jail population management plan describes existing and new initiatives—many of which align with MW Consulting policy levers—that support overarching goals of safe jail population reduction, reduced recidivism, and improved wellbeing and community supports for justice-involved individuals

- Ongoing commitment and urgency by all system partners will be key to success, along with funding prioritization
- MW Consulting will work with departments leading initiatives to capture information and data to further inform jail population projections
- Additional project-specific projections anticipated to be available for presentation to your Board within next 6 months
